




Ordering New Fields




EVC Form: New Per Packet Class of Service (**PP COS**) field.






Multi - EC Form: New Other Exchange Company Desired Due Date (**OECDDD**) field on MEC Form.

ASR Form: RTR Valid values are only F – FOC only, N – No response required, S – Send FOC and DLR.





FG A Form: SR Field - Add valid value P = Path Protection.

WAL Form: SR Field - Add valid value P = Path Protection.

Trunking Form: SR Field - Add valid value P = Path Protection at Primary Location.

Transport Form: SR Field - Add valid value P = Path Protection at Primary Location, 8 = Path Protection at Interoffice Facility and P = Path Protection at Secondary Location.




Confirmation Form: Remove CDLRD and FCDLRD fields from Confirmation Notifications.
